# HOLLYWOOD CASINO TOLEDO HOLIDAY BUCKS SWEEPSTAKES RULES AND REGULATIONS

### Promotional Period:

- 1. The promotional period will be Friday, November 1, 2019 from 5:00AM to Wednesday, December 25, 2019 at 8:00PM.
- 2. Drawings will be held every Wednesday in November and December 2019 from 2:00PM-8:00PM.

#### Eligibility:

- 1. Open to all mychoice members.
- 2. Must be 21 years of age or older to obtain a mychoice card.
- 3. No purchase necessary to receive a mychoice card.
- 4. Participants can receive twenty five (25) free entries during the promotional period by swiping their mychoice card at a kiosk in the Promotions Area every Wednesday.
- 5. For every fifty (50) tier points earned during the promotional period, participants will earn five (5) additional entries into the drawings.
- 6. It is the responsibility of the participant to ensure they have their card properly inserted into any slot machine reader to track their tier points.
- 7. Entries are applied to a player's mychoice account based on the date and time their player's card is removed from the slot machine or rating is closed at a table game.
- 8. Entries must be activated within thirty (30) minutes of each drawing time by inserting their mychoice card into any slot machine reader with at least one minimum bet, rated table game with a minimum bet or swiping at a kiosk in the Promotions Area.
- 9. A participant must ask to be rated at a table games to earn points.
- 10. Qualifying mychoice members can win a total of one (1) prize per drawing day.
- 11. The Poker Room is not eligible for this promotion.

## Implementation:

- 1. On each promotion day, one (1) winner will be electronically selected every hour to play a game.
- 2. Participants will select an envelope on the game board. Each envelope will contain a monetary denomination. Participants will select a total of four (4) envelopes which will be added together by a Marketing Representative.
- 3. The participant will receive the total amount of their envelopes in FREE SLOTPLAY/FREE BET. If the envelopes add up to exactly one thousand five hundred dollars (\$1,500), the participant will win one hundred thousand dollars\* (\$100,000) CASH. \*The \$100,000 prize is insured through Odds On Promotions.
- 4. In the event the guest hits the top prize of one hundred thousand (\$100,000), the promotion will be stopped and a manager will be contacted to verify the jackpot. A photo will be taken to record the prize amount and submitted to the insurance

company, Odds on Promotion. The promotion will continue once all procedures are completed for the insurance company.

- 5. Participants will have five (5) minutes to report to the Promotions Area between High Limit and the Poker Room to claim their prize.
- 6. If the winner does not claim their prize in the allotted time another name will be drawn. This will continue until we have a winner.
- 7. Drawings will be announced over the internal PA system and displayed on the promotion TVs located around the casino floor. It is the responsibility of the participant to hear their name being called.
- 8. Time limits will be strictly enforced.

# **General Rules:**

- 1. Persons on the Ohio Voluntary Exclusion List are not eligible to participate in this program.
- 2. A valid government issued photo ID must be shown upon request to verify age, identity and claim prize within the allotted time frame.

- 4. Participants agree to the use of his or her name, city, state, photograph, and recorded image for all forms of advertising and promotional purposes without charge or additional compensation.

- 6. FREE SLOTPLAY prizes will be paid out in increments no greater than \$5,000 per month.
