

**HOLLYWOOD CASINO TOLEDO**  
**OPEN CASTING CALL EVENT**  
**OFFICIAL RULES AND REGULATIONS**

**Promotional Period:**

1. Hollywood Casino Toledo will host an Open Casting Call Event from 3:00 PM - 7:00 PM on Friday, May 17, 2024. The casting call will be planned/executed by representatives of Twentieth Century Studios.
2. Filming of the Movie (as defined below) will take place at Hollywood Casino Toledo from approximately Wednesday, June 12, 2024, through Friday, June 24, 2024.

**Eligibility:**

1. Open to all PENN Play members.
2. Must be 21 years of age or older to obtain a PENN Play card.  
No purchase is necessary to receive a PENN Play card.

**Implementation:**

1. Hollywood Casino Toledo will host an Open Casting Call Event that will be planned/executed by representatives of Twentieth Century Studios. The event will take place in H Lounge.
2. A Penn Play card is not required to participate in the Open Casting Call Event.
3. All PENN Play members who attend the Open Casting Call Event may visit a Hollywood Casino Toledo representative in H Lounge to claim (1) one entry into a drawing for an extra role in a new upcoming movie (the "Movie") by presenting their player's card (the "Open Call Drawing").
4. No additional entries may be claimed or earned in connection with the Open Casting Call Event or Open Call Drawing. No purchase necessary to claim (1) one entry.
5. At 5:00PM on **Tuesday, May 21, 2024 at 5:00PM** (1) one member who claimed a entry in the Open Call Drawing will be randomly selected to receive an extra role in the Movie which is scheduled for shooting between approximately June 12-24, 2024 (with the specific date for such extra role to be selected by Twentieth Century Studios in its sole discretion). Odds of winning depend on the total number of eligible entries received.
6. Selected members do not need to be present at the Hollywood Casino Toledo **Tuesday, May 21, 2024 at 5:00PM** to receive the extra role.

**Official Rules:**

1. Persons on the Ohio Voluntary Exclusion List are not eligible to participate in this promotion.
2. The ability to claim the extra role is subject to and contingent upon the selected participant's proof of identity and employment eligibility as required by the Immigration Reform and Control Act of 1986.
3. A valid government issued photo ID must be shown upon request to verify eligibility.
4. Participants must sign a valid I-9 form and provide documentation as set forth in the Form I-9 to show identity and authorization to work to claim the extra role.
5. Participants agree to the use of his/her/their name, city & state, and photograph for advertising and promotional purposes without charge or additional compensation.
6. To the extent permitted by applicable law, Twentieth Century Studios may require the selected participant to pass a background screening or security check, in the form and to the extent permitted by such applicable law (including without limitation in person meetings) to claim the extra role and the selected participant may be disqualified if such background screening or security check indicates that the selected participant presents a threat to any other person, in Twentieth Century Studios' sole discretion. Twentieth Century Studios reserves the right in its sole discretion, to disqualify any selected participant if the results of

such security/background check reveal that such selected participant has been convicted of a crime or an act of moral turpitude in Twentieth Century Studios' sole discretion.

7. The contents of Movie are at the sole discretion Twentieth Century Studios. Neither Hollywood Casino Toledo nor Twentieth Century Studios make any representation, warranty or guarantee that any visual or aural recording featuring the selected participant will be included in the final version of the Movie as released.
8. Participation in the Open Casting Call Event does not guarantee any type of meeting or photo opportunity with any specific cast member or talent from the Movie.
9. Participants are only eligible to win one (1) extra role across all of the Hollywood Casino Toledo's promotions relating to the Movie.
10. Employees of Hollywood Casino Toledo and/or Twentieth Century Studios, including their subsidiaries, affiliates, related or parent companies and the immediate family and/or household members of each are not eligible to participate in this promotion.
11. Hollywood Casino Toledo is not responsible for lost or stolen cards, cash, coupons, or lost/misdirected mail.
12. Promotion benefits are not transferable between patrons. Determination will be made at the sole discretion of Hollywood Casino Toledo.
13. Hollywood Casino Toledo may disqualify any participant based upon fraud, dishonesty, and violation of these Official Rules or other misconduct. Additionally, if the selected participant engages in behavior that, as determined by the Hollywood Casino Toledo or Twentieth Century Studios, in their sole discretion, is obnoxious or threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Hollywood Casino Toledo or Twentieth Century Studios reserve the right to determine that the selected participant is ineligible to claim the extra role, and no compensation shall be due to the selected participant.
14. Hollywood Casino Toledo may refuse a participant's entry attempt if it is determined that the true cardholder of the PENN Play account is not present at the time of entry.
15. The selected participant must complete any paperwork required to claim the extra role, including but not limited to any additional releases, contracts, waivers required by Twentieth Century Studios. Failure to comply with the foregoing shall render the selected participant ineligible to claim the extra role.
16. Participants generally acknowledge that Twentieth Century Studios reserves the right in its sole discretion, to disqualify the selected participant if such individual is determined to be ineligible.
17. Use of the PENN Play card to obtain an entry indicates acceptance of these Official Rules.

All participants irrevocably and expressly waive any right to seek and/or obtain rescission and/or equitable and/or injunctive relief in connection with the Movie or against Twentieth Century Studios or its affiliates', successors' and assigns' use of the selected participant's services in connection with the Movie due to breach or alleged breach of the Official Rules set forth herein.
21. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights or obligations of participants or Hollywood Casino Toledo in connection with the promotion, are governed by and construed in accordance with the laws of the

State of Ohio, without giving effect to any choice of law or conflict of law rules that would cause the application of the laws of any other jurisdiction; provided that any and all disputes, claims and causes of action arising out of or connected with the intellectual property of Twentieth Century Studios or the claiming of the extra role, shall be resolved individually, without resort to any form of class action, shall be governed and construed in accordance with the laws of the State of Ohio and in the event of any dispute, all entrants irrevocably consent to the jurisdiction of the state and federal courts located in Ohio to resolve such disputes. In addition, Hollywood Casino Toledo may change, modify, or cancel this promotion at any time with Ohio Casino Control Commission (OCCC) notification.
